

THE ACC LIVERPOOL GROUP SECURITY MEASURES

UK Threat Level = Severe

Security Strategy measures = Heightened

EVENT SECURITY:

Conferences and Trade Exhibitions:

Access to Loading bay's (Rig and de-rig)

- Access to any of the venue loading bays will only be permitted during tenancy.
- All vehicles entering the loading bay will be subject to a vehicle search as condition of entry.
- All client staff, event crew, contractors and exhibitors will be subject to a verification and accreditation check at the entrance to the venue. To facilitate this the following minimum measures will be adhered to:
 - A list of companies involved in the event build and breakdown will be provided.
 - All staff to have clearly visible accreditation that links them to this company.
 - Accreditation can only be in the form of a photo ID or branded uniform

Specifics and criteria will be detailed in the event schedules under the section titled – security.

- All client staff, event crew, contractors and exhibitors will be subject to a profiled bag search upon arrival at the venue.
- Deliveries for the event can only be accepted during tenancy. Outside of these times, only with the express permission of the Event Manager or an Operations Manager.

Event open

- Event Security measures will be deployed as per the Risk Category allocated. Min security level on any event will be the use of the LFA WTMD.
- Delegates and exhibitors will be encouraged to check in at Hotels and avoid bringing any unnecessary bags to the venue
- All delegates/exhibitors must have conference accreditation at all times.
- Bags and coats cannot be accepted at the cloakroom unless conference accreditation is presented.

Consumer Exhibitions:

Access to Loading bay's (Rig and de-rig)

- Access to any of the venue loading bays will only be permitted during tenancy.
- All vehicles entering the loading bay will be subject to a vehicle search as condition of entry.
- All client staff, event crew, contractors and exhibitors will be subject to a verification and accreditation check at the entrance to the venue. To facilitate this the following minimum measures will be adhered to:
 - A list of companies involved in the event build and breakdown will be provided.
 - All staff to have clearly visible accreditation that links them to this company.
 - Accreditation can only be in the form of a photo ID or branded uniform

Specifics and criteria will be detailed in the event schedules under the section titled – security.

- All client staff, event crew, contractors and exhibitors will be subject to a profiled bag search upon arrival at the venue.
- Deliveries for the event can only be accepted during tenancy. Outside of these times, only with the express permission of the Event Manager or an Operations Manager.

Event open

- Event Security measures will be deployed as per the Risk Category allocated. Min security level on any event will be the use of the LFA WTMD.
- All exhibitors must wear clear event accreditation at all times.

Please note that the above measures are the minimum security measures that we adhere to as a venue. These measures may be increased in response to an increase in the UK Threat level or as a specific risk to our industry.
