

Martin has written journal articles on various aspects of high-risk foot care and lower limb vascular disease. He is an elected Council member for the College of Podiatry.

Sue Matthews is a Vascular Specialist Podiatrist working in Greater

Manchester. She previously worked as a High Risk Specialist Podiatrist working within complex wound care and is an independent non-medical prescriber. Antony graduated from the Northern College of Podiatry in 1990 and quickly became interested in foot and

surgery. After passing membership exams with the podiatry association in 1994, he secured a surgical training post in South Derbyshire. After gaining his fellowship in Podiatric Surgery in 1997, Antony continued his training as an SpR in podiatric surgery before being appointed as a consultant podiatric surgeon in 2000.

Antony is employed as Consultant and Clinical Head of Podiatric Surgery with Doncaster and Bassetlaw Hospitals NHS Foundation Trust as well as offering NHS and Private treatments with Ramsay Park Hill Hospital Doncaster and Holywell Healthcare in Chesterfield.

Antony was elected Dean of the Faculty of Podiatric Surgery in 2009, a post which he held for 3 years. He is currently chair of Clinical Governance. He is also Chair of the MAC at Ramsay Park Hill, the first Podiatric surgeon to hold this position.

In 2020 Antony was elected to fellowship of the Faculty of Podiatric Medicine within the Royal College of Physicians Surgeons of Glasgow.

MSK considerations in foot surgery

This workshop aims to review the current concepts in Podiatric Biomechanics and provide some guidance on simple clinical assessments and the role of plantar pressure analysis to build a biomechanical profile for each patient. This will then be related to common clinical conditions and the implications to pre-surgical management, surgical planning and managing post operative problems.

This will be of value to surgical trainees, Podiatric surgeons wishing to update their knowledge or are considering a biomechanical service and any clinician supporting a surgical team.

Trevor is the clinical lead for podiatric medicine & surgery at Homerton University NHS Foundation Trust. He


